Introduction

During the COVID-19 pandemic, a Chief School Administrator in New Jersey developed a revolutionary system known as Family Support Specialists Systems [™] (FSS). This school leader immediately placed his school under a unique Incident Command System (ICS). An essential branch of this system was FSS Command. FSS is an ICS/NIMS system that allows schools to more effectively monitor attendance, IT, academic support, materials distribution, SEL support, and family wellness. It fosters family relationships and communication better than traditional school organizational systems. This system produces an elite team of specially trained school personnel that resemble a special forces military team. They are dressed in a manner different than regular staff and are trained to take on difficult missions and completing them with military precision, courage, and discipline.

<u>Background</u>

Family Support Systems revolutionized how schools operate during the COVID-19 Pandemic and post COVID. This system was created and implemented by Mr. Alvaro "Al" Cores in his K-6 school under the pressures of the COVID-19 Pandemic. This ICS emergency operations system redeployed school personnel during the COVID-19 Pandemic. This unique system was not designed for use by schools during a major crisis such as an active shooter, gas explosion, or natural disaster. Existing school crisis plans and ICS systems addressed these issues. When COVID-19 was announced as a state of emergency for both the United States of America and the State of New Jersey, Mr. Cores invoked a school crisis plan that was *meant to be used for sustained periods of time*. Since his school was located within both the United States and New Jersey, Mr. Cores, the Chief School Administrator and Incident Commander, decided that the school, by default, was locked into a perpetual state of crisis under two different states of emergency. Unlike an active shooter scenario, this crisis would not be a one-day event. Mr. Cores anticipated that COVID would be a long term event and devised a unique deployment and cross-training of school personnel. He likened COVID-19 to the asteroid impact that eliminated the dinosaurs. It was a shocking and dramatic evolutionary event that forced schools to adapt quickly or perish. There are many well documented cases of schools that did not rise to meet the needs of their students and families during the COVID-19 Pandemic. The FSS System is the only school organizational that can be turn keyed in any school to both improve their operations during regular operations and prepare them for successful operation during the next unforeseen, protracted emergency.

FSS Description

The Family Support Specialist System (FSS) ™ cross-trained school personnel in school counseling, attendance, family wellness checks, academic systems, logistics, and IT troubleshooting. Instead of having one social worker, one attendance officer, and one IT person at his school, Mr. Cores cross-trained 17 staff members in the areas of social work, SEL, attendance, IT trouble shooting, logistics, and academic systems. This solved a practical problem in the education sphere referred to as the "COVID Bottlenecks." The five areas in public schools suffering the paralyzing bottlenecks of workflow during the COVID-19 Pandemic were as follows: IT support, counseling, attendance, academic engagement, and family wellness. The FSS Team worked closely with the all the school's stakeholders to resolve these crucial workflow bottlenecks. The FSS system also gave broader job responsibilities to paraprofessionals, office staff, security officers, and other school staff. This ICS System lead to dramatic support of families, increased home visits, revamped attendance protocols, wellness check protocols, IT protocols, and documentation. The Atlantic County of Education recognized this as a Best Practice in 2021. The system was shared with the New Jersey Department of Education in 2021. Mr. Cores and his team (pictured below) conducted home visits continuously during the COVID-19 Pandemic. The FSS System has been utilized until the present day and has revolutionized the way schools communicate with families and support all of its stakeholders. This innovation has implications for school operations post pandemic and can keep any school in a constant state of readiness for the next national emergency. FSS also enhances communications, boosts attendance, supports school climate, increases staff morale, supports learning, and promotes a school's visibility in its surrounding community.
